COUNTY OFFICIAL PLAN AMENDMENT (OPA) PROCESS

1. Pre-consultation



- Provide the applicant an opportunity to discuss their proposal, inform them the next step and all the required documents to be submitted to the Planning Department if they decide to proceed
- Refer to County By-law 2019-04



Council must make decision within from **120 days** notification of the applicant that the application is complete

2. Application Submission

- County must notify the applicants within 30 days of receiving a complete application, otherwise they can appeal to the Local Planning Appeals Tribunal (LPAT)
- Notify the public after application is deemed complete or provide an explanatory letter if the submission is incomplete

3. Processing Complete Application



- Notification of amendment to identified agencies and persons within 15 days of a notice of completeness having been issued
- Made available to the public within 15 days

4. Council Meeting

- Notify applicant and public of the Council Meeting
- Hold meeting and receive direction from Council (a preliminary report will be presented)

Informal Public Meeting

 Council may deemed to undertake additional public consultation as the result of the Council meeting

5. Comments and Report

- Preliminary comments will be issued to the applicant and receive the applicant's response
- A recommendation report will be prepared by the County

6. Statutory Public Meeting & Council Decision

- Notice of Public Meeting must be given at least 20 days prior to the date of the meeting.
- Final recommendation report for the proposed OPA will be presented to Council
- This meeting will provide an opportunity for the public to make representations with respect to the proposed amendment

8.Local Planning Appeal Tribunal (LPAT)

- Decisions may be appealed to the LPAT
 within 20 days from the date that MMAH
 issue the notice of decision
- LPAT Appeal process can be found: https://elto.gov.on.ca/tribunals/lpat/lpatprocess/

7. Forward to the Ministry of Municipal Affairs (MMAH) and Housing for Approval

- All County OPAs are subject to approval by MMAH
- Forward to the Ministry within 15 days after the plan is adopted by Council
- Once MMAH has issued a decision a wirtten notice will be provided

9. OPA Implementation

 The amendment or part of the amendment that was adopted that is not subject of an appeal, comes into effect as an OPA or part of the OPA on the day after the last day for filling a notice of appeal





6. Council & Statutory **Public Meeting**


- Local municipality will hold public meeting and receive direction from the local council
- The County are circulated on local applications to provide input and comments
